

MINUTES OF THE MEETING
OF THE
DUPONT CIRCLE ADVISORY NEIGHBORHOOD COMMISSION
HELD JANUARY 25, 1989

A meeting of the Dupont Circle Advisory Neighborhood Commission (ANC 2B) was held on Wednesday, January 25, 1989 at 7:30 p.m. Present were all commissioners (Bass, Evans, Grandis, Gaugler, Moses and Rieffel) and Vernon Palmer.

The motion by Mr. Bass, seconded by Mr. Gaugler, to adopt the minutes of the previous meeting, held January 11, 1989 was approved unanimously.

Mr. Grandis presented items from incoming mail:

-The ANC training session for commissioners throughout the city will be held on Saturday, January 28, 1989.

-Proposed rulemaking on procedures for submitting filings have been issued. Mrs. Rieffel is to work with Mr. Evans to study these.

-A BZA hearing on 1527 16th Street will be held on February 12, and will be placed on the agenda of the February 8 ANC meeting. This is in the SMD of Mr. Bass.

-A letter has been received concerning chancery use at 1725 N Street. This is in the SMD of Mr. Evans.

-The second district Police Advisory Council will meet at 8 p.m. on February 1.

-A roundtable discussion will be held on the Cosmos Club alley closing; no date has been set.

The motion by Ms. Moses, seconded by Mr. Grandis, to support the request of the American Home Economics Association to amend BZA Order No. 9702, dated July 8, 1969 was approved, on the condition that no space be used for medical purposes, and that one or more law firms do not occupy more than one floor or the equivalent of more than one floor.

The motion by Mr. Gaugler, seconded by Mr. Grandis, to support the request for a liquor license at 1010 15th Street (ABC Application No. 28189), Taste of China 2, was approved with Mr. Bass voting against and other commissioners present voting in favor.

The motion by Ms. Moses, seconded by Mr. Grandis, that the ANC pass a continuing resolution until the ANC has approved its budget for the current year was approved unanimously.

The motion by Mr. Grandis, seconded by Mrs. Rieffel, that the ANC adopt the letter to Council Chairman Clarke concerning linkage was approved unanimously. This letter opposes Bill 8-1, the "Street or Alley Closing and Zoning Density Increase Linkage Amendment Act of 1989."

The motion by Mr. Grandis, seconded by Ms. Moses, to approve the letter to Stephen Raich at the Historic Preservation Office concerning delays in providing the ANC timely notice of the Historic Preservation Review Board, was approved, with all commissioners voting in favor, except Mr. Gaugler, who abstained.

The motion by Mr. Bass, seconded by Ms. Moses, that the Treasurer, Secretary and Chairman of the ANC be authorized to continue the ANC's deposit account at the National Bank of Washington was approved unanimously.

The meeting was adjourned at 9:25 p.m.
