

MINUTES OF ACTIONS TAKEN BY ANC 2B, MAY 11, 1988

Dupont Circle Advisory Neighborhood Commission 2B met at a public meeting on May 11, 1988 at St. Thomas' Church at 7:30 p.m. Commissioners present were Bass, Grandis, Maggi, Rieffel, Schwager and Schwartz. Comm. Maxwell was absent.

1. **Motion** by Comm. Maggi, seconded by Comm. Schwager, to approve the minutes of ANC 2B's meeting on April 27, 1988. **Motion adopted**, 3 yeas, 1 abstention (Comm. Schwartz); (Comms. Grandis and Rieffel were not present for the vote).

2. **Motion** by Comm. Grandis, seconded by Comm. Maggi, to establish a committee to examine and make recommendations at ANC 2B's May 25 meeting on the following bills: 7-441, "District of Columbia Substance Abuse Treatment and Prevention Act of 1988;" 7-442, "Youth Offender Community Service Amendment Act of 1988;" 7-443, "District of Columbia Compulsory School Attendance, School Day Care, and Evening School Use Amendment Act of 1988;" and 7-444, "Protection of Children from Exposure to Drug-Related Activity Amendment Act of 1988." **Motion adopted**, 5 yeas, 1 abstention (Comm. Maggi).

3. **Motion** by Comm. Grandis, seconded by Comm. Maggi, to oppose any demolition of the historic building at 1808 Florida Avenue, N.W. (although use of part of the building as a trash room is supported to the extent permitted by zoning regulations); and to oppose the curb cut and elimination of a mature, 50-foot tree, as proposed by the owner. **Motion adopted**, 6 yeas.

4. **Motion** by Comm. Maggi, seconded by Comm. Schwager, to support BZA Application No. 14802 of Joseph and Janet Passonneau for a variance from the percentage of lot occupancy requirements and a variance from the floor area ratio requirements to construct an accessory garage in an R-5-B district at premises 2114 O Street, N.W. (Square 69, Lot 147). **Motion adopted**, 6 yeas.

5. **Motion** by Comm. Schwager, seconded by Comm. Grandis, to support the application for an unenclosed sidewalk cafe for C.F. Folks restaurant, 1225 19th Street, N.W. **Motion adopted**, 6 yeas.

6. **Motion** by Comm. Maggi, seconded by Comm. Schwager, to ask the Zoning Administrator to investigate whether the premises at 2020 O Street, N.W. are being put to uses in violation of the zoning regulations, and, if so, to take appropriate action to halt the violation(s). **Motion adopted**, 6 yeas.

The Commission adjourned at 9:11 p.m.
