**MINUTES OF THE NOVEMBER 18, 1992 MEETING OF THE DUPONT CIRCLE  
ANC 2B**

The Dupont Circle ANC 2B held a regularly scheduled meeting on November 18, 1992 at St. Thomas Parish. Commissioners Bass, Grandis, Meier, Taylor, and Schwager were present. Chairman Bass called the meeting to order at 7:40 p.m. Captain Swope of the second district, and Sgt. Wilkinson and Officer Zelinka of the third district gave police reports.

**Motions:**

**1) Sabina's Restaurant, 1813 M Street, N.W., ABC Application No. 6254**

Ms. Schwager moved and Ms. Taylor seconded, a motion that ANC 2B oppose the renewal application of Sabina's Restaurant for a class "CR" license because its operation is disturbing the peace, order and quiet of both the commercial and residential environment of the neighborhood and adversely impacting the economic vitality of the surrounding commercial area. This motion passed unanimously.

**2) Fraternity House, 2123 Twinning Ct., N.W., ABC Application No. 9315**

Ms. Taylor moved and Mr. Meier seconded, a motion that ANC 2B support the renewal application of Fraternity House, 2123 Twinning Ct., N.W. for a class "CT" license. This motion passed unanimously.

**3) Badlands, 1415 22nd Street, N.W. ABC Application No. 10819**

Ms. Taylor moved and Mr. Meier seconded, a motion that ANC 2B support the renewal application for Badlands, 1415 22nd Street, N.W. for a class "CT" license. This motion passed unanimously.

It was also agreed to send a letter to the PMI management regarding the lot on 21st and P Streets, to request that its overhead lights be kept on past midnight.

#### **4) 17th Street Liquor License Moratorium**

Mr. Bass moved and Ms. Taylor seconded, a motion that ANC 2B adopt the petition for 5-year renewal of the ABC moratorium on 17th Street, including a specific provisions that ANC 2B and the DCCA be given notice by the ABC Board of any application to change seating capacity and that if approval is granted by the ABC Board before this is done, that approval will be null and void. This motion passed unanimously.

#### **5) ANC 2B FY'93 Budget**

Ms. Taylor moved and Ms. Schwager seconded, a motion to approve the FY'93 ANC 2B budget. This motion passed unanimously.

#### **6) 11 Dupont Circle, N.W., HPA Application No. 92-482**

Mr. Grandis moved and Mr. bass Seconded a motion to authorize an expenditure of up to \$200 for a purchase of service contract with Richard Nettler to review the HPRB hearing proceedings of November 18 regarding 11 Dupont Circle, N.W. and advise the ANC of any legal options it might have. In addition, the ANC will notify the HPRB and staff advising of this decision and request they refrain from issuing any permits to allow renovation, construction or demolition on this site until the January HPRB meeting. This motion passed unanimously.

Mr. Grandis moved and Ms. Schwager seconded, a motion to send a second letter to Mayor Kelly stating the following: ANC 2B is disappointed by the recent action of the HPRB at its public hearing on November 18 regarding 11 Dupont Circle, N.W. ANC 2B would appreciate a disclosure of any and all contacts between the applicant, its attorneys, or the HPRB and/or staff and members of your administration on this matter. This motion passed unanimously.

#### **7) ABC Voluntary Agreements**

Mr. Bass moved and Mr. Grandis seconded, a motion to send a letter to the ABC Board stating that ANC 2B expects all voluntary agreements to be renewed automatically along with the license in question Pro Forma. If not, ANC 2B expects to be listed as an automatic protestant if the applicants will not sign a renewed voluntary agreement. This motion passed unanimously.

#### **8) Letter to Mayor Kelly**

Mr. Bass moved and Ms. Taylor seconded, a motion to send a letter to Mayor Kelly thanking her for recent actions taken by her administration in regards to Halloween

1992, domestic partnership, and the selection of the new D.C. Police Chief. This motion passed with Mr. Meier in abstention.

The meeting adjourned at 10:45 p.m.
