

**ANC 2B DUPONT CIRCLE ADVISORY NEIGHBORHOOD COMMISSION REGULAR
MEETING MINUTES**

Wednesday, October 14, 2009 Jewish Community Center

The October Regular Meeting of the Dupont Circle Advisory Neighborhood Commission (Commission or ANC 2B) was called to order by Chairman Silverstein at 7:00 pm. The Commissioners identified their Single Member Districts (SMDs). Present were: Mike Feldstein (2B01), Bhavna Patel (2B02), Bob Meehan (2B03), Jack Jacobson (2B04), Victor Wexler (2B05), Mike Silverstein (2B06), Phil Carney (2B07), Will Stephens (2B08) and Ramon Estrada (2B09). The Chairman noted the presence of a quorum.

Approval of Minutes

Commissioner Feldstein made a motion to approve the September minutes, subject to technical corrections. Commissioner Stephens seconded the motion. The motion carried unanimously (9-0).

Public Announcements

Commissioner Estrada announced the opening of Masa 14 at 1825 14th Street NW.

Commissioner Stephens announced a plan to update the U Street Corridor and noted that the contractors have put together a newsletter to explain the status of the project.

Commissioner Feldstein noted that a recent fundraiser raised over \$1,000 for Dupont Circle Village.

Commissioner Silverstein announced that the first installment of the amenities package related to the PUD project at 1616 Rhode Island Avenue would be dispersed to the DCCA in the near future.

Robin Diener announced the Dupont Circle House Tour on October 18 from 12 - 5pm.

A Dupont Circle Village meeting will take place on October 20th at 6:30 PM at Sumner School on 17th and N Streets NW.

Paul Williams, HDCMS, announced the Taste of Dupont event on November 17th. Tickets can be purchased at a participating restaurant.

A resident announced their plan to build a house at a vacant lot at 17th and P Streets NW.

Public Safety

Commissioner Jacobson introduced Lt. John MacDonald, MPD, PSA 208. He noted that crime rates increase with the holiday season.

The Dupont Circle Public Safety Committee normally meets every third Tuesday of the month at 7:00 PM at the Metropolitan Police Department (MPD) station at 1620 V Street NW.

Commissioner Carney expressed concern over the MPD towing cars at 1 AM in the morning.

Commissioner Silverstein expressed concern over a recent article over the MPD's plan to allow GLLU to whither away by attrition.

Committee Reports

17th Street Working Group

Commissioner Jacobson noted that Paul Williams, HDCMS, is looking for a business representative for the Working Group. Commissioner Feldstein is seeking an academic member for the Group. Commissioner Jacobson and Robin Diener are seeking a citizen member. The Working Group is putting together a strategy for the next six months.

Resolution to Establish ABRA Policy Committee

Commissioner Stephens made the following motion:

Be it resolved that the Commission hereby establishes the ABRA Policy Committee (“Committee”) as a standing committee;

Be it further resolved that the purposes of the Committee shall be:

- To inform the Commission and the public about issues related to alcoholic beverage control; and
- To make the work of the Commission related to alcoholic beverage control both more transparent and more efficient;

Be it further resolved that to carry out these purposes, the Committee shall undertake the following activities:

- To propose standard guidelines related to liquor-licensed establishments for the ANC 2B Policies & Procedures Manual;
- To create and maintain up-to-date model Voluntary Agreements for the Commission's use in negotiating with neighborhood restaurants, bars, clubs, and liquor stores;

- To keep track of policies related to liquor-licensed establishments – including legislation, new regulations, court rulings, and other new developments;
- To liaise with the Alcoholic Beverage Regulatory Agency (ABRA) and the appropriate D.C. Council committees and staff;
- To report on new developments to the Commission and community;
- To propose changes or amendments to existing liquor policies for the Commission and the District;
- To maintain a committee web page — including a page that provides up-to-date public access to all Voluntary Agreements and Moratoria within the Commission’s boundaries;
- To carry out such other tasks as the Commission may delegate from time to time.

Be it further resolved that in accordance with the Commission’s requirement that each committee be served by at least two Commissioners, the following Commissioners shall serve as members of the Committee: Commissioner Estrada, Commissioner Stephens, and Commissioner Silverstein;

Be it further resolved that in accordance with the Commission’s requirement that each committee be chaired by a Commissioner, the Committee Co-Chairs shall be Commissioners Estrada and Stephens;

Be it further resolved that as its first task, the Committee shall search out and solicit volunteers from the community — including residents and business community representatives — to be nominated to serve as non-Commissioner members of the Committee;

Be it further resolved that the Committee’s nominees shall be considered by the Commission at the Commission’s November 2009 public meeting.

Commissioner Estrada seconded the motion. The motion carried unanimously (9-0).

Resolution to Establish a Zoning, Preservation, and Development Committee

Commissioner Feldstein made the following motion:

Be it resolved that the Commission hereby establishes a Zoning, Preservation, and Development Committee (“Committee”) as a standing committee;

Be it further resolved that the purposes of the Committee shall be to promote preservation of the historic, architectural, and residential character of the Dupont Circle area while encouraging its economic and social vitality;

To help achieve these purposes the Committee will:

- Establish and maintain on-going working relations with those public and private entities with similar goals and purposes, such as the Historic Preservation Review Board, Board of Zoning Adjustment, the Zoning Commission, the Dupont Circle Conservancy, the DC Office of Planning, and other stakeholders.
- Track and, when appropriate, comment on zoning and historic preservation policy and developments.
- Convene special meetings to hear applications on major projects and to make recommendation to the Commission as a whole.
- Maintain a committee web page, including links to relevant organizations.
- When appropriate, seek the advice of outside expertise, such as architects and historic preservationists, to guide the Committee in its work.
- Propose related policy positions for the Commission's Policy and Procedures Manual.
- Assist with ANC training as related to the goals and purposes of this Committee.

Be it further resolved that in accordance with the Commission's requirement that each committee have at least two Commissioner members, Commissioners Estrada, Feldstein, Meehan, and Patel shall serve as members of the Committee;

Be it further resolved that in accordance with the Commission's requirement that each committee be chaired by a Commissioner, the Committee Chair shall be Commissioner Feldstein;

Be it further resolved that as its first task, the Committee shall search out and solicit volunteer experts from the community — including residents and representatives of not-for-profit entities — to be nominated to serve as non-Commissioner members of the Committee;

Be it further resolved that the Committee's nominees shall be considered by the Commission at the Commission's November 2009 public meeting.

Commissioner Silverstein seconded the motion. The motion carried unanimously (9-0).

Resolution to Establish Community Involvement Committee

Commissioner Feldstein made the following motion:

Be it resolved that the Commission hereby establishes a Community Involvement Committee ("Committee") as a standing committee;

Be it further resolved that the purposes of the Committee shall be:

- To promote and encourage a wide range of community activities that help meet the needs of Dupont Circle citizens.
- To promote the social and economic development of our community.

To help achieve these purposes the Committee will:

- Liaise with a wide range of existing community service organizations, other stakeholders, and relevant organizations.
- Explore the establishment and operation of a community grants system for the Commission.
- Assist and nurture community service events, fundraisers for community groups, and community activities.
- Maintain a committee web page, including links to community organizations and community service opportunities.
- Seek ways to nurture greater social capital.
- Carry out such other tasks as the Commission may from time to time designate.

Be it further resolved that in accordance with the Commission's requirement that each committee have at least two Commissioner members, Commissioners Stephens, Feldstein, Wexler, and Silverstein shall serve as members of the Committee;

Be it further resolved that in accordance with the Commission's requirement that each committee be chaired by a Commissioner, the Committee Co-Chairs shall be Commissioners Feldstein and Stephens;

Be it further resolved that as its first task, the Committee shall search out and solicit volunteers from the community—including residents and representatives of not for profit entities to be nominated to serve as non-Commissioner members of the Committee;

Be it further resolved that the Committee's nominees shall be considered by the Commission at the Commission's November 2009 public meeting.

Commissioner Stephens seconded the motion. The motion carried (9-0).

Commissioner Reports

Report on Dog Park Community Meeting of Oct. 13, 2009 & Proposed Resolution on Park Rules

Commissioner Meehan noted that the community held a meeting on Dog Park rules.

Commissioner Meehan made the following motion:

Resolution to support the existing posted hours for the S St dog park on an interim basis

Whereas, DPR and the ANC, along with Friends of S&T St Parks and Circle Dogs, sponsored a public meeting October 13, 2009, to review the experience of the park since its opening in early September; and

Whereas, DPR had posted closing hours of 8:00 PM but the general dog park regulations permit lighted dog parks to stay open up to 10:00 PM and the S St park is lit; and

Whereas, dog owners wanted the closing hours extended beyond 8:00 PM, but residents living close to the dog park wanted the hours to stay as they are; and

Whereas, DPR is opening and closing the park on an interim basis until Circle Dogs has the capacity to assume this responsibility but cannot commit to closing after 8:00 PM; and

Whereas, Circle Dogs has not yet signed a Memorandum of Understanding of its responsibilities for the care and management of dog park operations;

Therefore, be it resolved that ANC 2B supports continuing the existing closing hour of 8:00 PM until (1) Circle Dogs has signed its Memorandum of Understanding with DPR, (2) the ANC and DPR hold a follow up meeting to discuss hours and all the other issues that surfaced at the October 13 meeting, (3) Circle Dogs can demonstrate that it will be able to assume the responsibility of enforcing park hours and (4) Circle Dogs can demonstrate that the concentration of dogs and dog owner responsibility in managing barking dogs merit consideration of a later closing hour.

Commissioner Stephens seconded the motion. The motion carried unanimously (9-0).

Neighboring Jurisdiction Reports (West End/Foggy Bottom, Adams Morgan, Kalorama, Shaw/Mt. Vernon, Logan Circle, Georgetown)

None.

General

Resolution requesting DDOT to provide a minimum of 2 weeks notice to residents and ANCs of street, sidewalk, and alley projects and to provide for consultation with ANCs on changes to materials or appearance

Commissioner Jacobson expressed concern that DDOT did not notify the ANC or community regarding recent sidewalk construction which limited handicap access on 17th and Corcoran Streets NW. Commissioner Silverstein pointed out to the DDOT representative that Commissioner Jacobson had sent DDOT a memo on August 29 requesting DDOT notify the

Commission and community regarding any planned construction. Commissioner Jacobson requested DDOT commit to a public meeting, to which DDOT agreed.

Commissioner Stephens made the following motion:

Whereas DDOT has worked productively with the Dupont Circle ANC (ANC 2B) in the past to host community meetings and allow for community input on major streetscape and street reconstruction projects — including the forthcoming projects on 17th Street NW and 18th Street NW; and

Whereas other sidewalk, alley, and street resurfacing projects — while not considered “major” projects by DDOT — are also disruptive to residents and businesses on the affected blocks; and

Whereas residents and businesses require a minimum amount of time to plan ahead for such projects, including making different arrangements for parking, commutes, meetings, customers, and ingress/egress from front and back entrances;

Whereas as one example, residents and businesses on the 1700 block of T Street NW received 1 business days’ notice of an entire sidewalk removal and reconstruction project in November 2008 and 4 days’ notice of a street resurfacing project in September 2009; and

Whereas such notice is insufficient to allow residents and businesses to make alternative arrangements and plan ahead; and

Whereas the sidewalk was also reconstructed from concrete to brick without any input from the community or any notice to the ANC; and

Whereas the DDOT website only provides information on the fiscal year (or two-year window) that such a project is planned;

Therefore be it resolved that ANC 2B requests DDOT to implement a system which allows for a minimum of two weeks’ notice to affected residents and businesses — and to the relevant ANC — of non-emergency resurfacing or reconstruction of sidewalks or alleys, or resurfacing of streets; and

Be it further resolved that where sidewalks or alleys are to be reconstructed in an entirely new material or look, that DDOT allow for public comment and input through the relevant ANC;

Be it further resolved that ANC 2B would be pleased to communicate and work with DDOT further on such a system of notice;

Be it further resolved that the Chairman send a letter to DDOT Director Gabe Klein and the Mayor’s Office in accordance with this resolution.

Commissioner Estrada seconded the motion. Commissioner Jacobson made a friendly amendment to the motion's first clause. The DDOT representative stated that Mr. Aaron Rose would contact the ANC to schedule a meeting with the community. The motion carried unanimously (9-0).

Special Guest: The Brookings Institution

A representative was not available to attend the meeting.

Presentation by David Peruzza re: 2009 High Heel Race

Mr. Peruzza was not able to attend the meeting. Commissioner Jacobson relayed details on the event to the Commission. Commissioner Jacobson noted that the High Heel Race is on October 27th. He has collected signatures and MPD support in ensuring traffic patterns are rerouted. Mr. Peruzza requests a letter of support. Commissioner Jacobson made a motion to send a letter of support. Commissioner Stephens seconded the motion. The motion carried unanimously (9-0).

Presentation by David Burd of EarthAid re: home energy benefits program

A representative was not present.

Presentation by Jeff Klein, representing Keegan Theater, operating out of Church Street Playhouse, regarding this season's activities.

A representative noted its upcoming shows in November and invited the community to visit its shows.

Resolution in Support of Full Marriage Equality

Commissioner Meehan made the following motion:

Whereas, on February 11, 2009, ANC 2B unanimously approved a motion urging the D.C. Council to introduce legislation recognizing the right of same-gender couples in the District of Columbia; and

Whereas, on October 5, 2009, the D.C. Council's Committee on Health introduced with overwhelming sponsorship of other Council members the Religious Freedom and Civil Marriage Equality Amendment Act of 2009, which extends the right to marry in the District to same gender couples; and

Whereas, the right to have one's bond of marriage recognized by the government is a fundamental right and a matter of basic human dignity; and

Whereas, the bond of marriage to sustain and support one another in love, companionship, shared economic responsibilities, loyalty, and aging is the same regardless of the gender or genders of the married couple;

Therefore, be it resolved that ANC 2B urges the D.C. Council to legalize same-gender marriages without delay; and

Be it further resolved that the Chairman send a letter to all D.C. Council members in accordance with this resolution with copies to all ANCs.

Commissioner Estrada seconded the motion. Commissioner Stephens made a friendly amendment, reflected in the resolution above. The motion carried unanimously (9-0).

Resolution in Support of D.C. Hatch Act Eliminating Restrictions on ANC Commissioner Political Activity

Commissioner Stephens made the following motion:

Whereas the Hatch Act, as currently interpreted, prevents ANC Commissioners from engaging in certain partisan political activity — such as fundraising for candidates in a partisan election, or standing as a candidate in a partisan election; and

Whereas limiting the political activity of ANC Commissioners, who are themselves elected officials and not government employees, is not rationally tied to any legitimate governmental interest and does not serve the purposes of the Hatch Act;

Therefore be it resolved that ANC 2B emphatically supports the establishment of a local D.C. Hatch Act which eliminates the restrictions on political activity for ANC Commissioners;

Be it further resolved that the Chairman send a letter in accordance with this resolution to the D.C. Council, Delegate Eleanor Holmes Norton, and any other appropriate officials.

Commissioner Estrada seconded the motion. The motion carried (8-0-1) with Commissioner Jacobson abstaining.

Resolution regarding Draft White-tailed Deer Management Program/Environmental Impact Statement for Rock Creek Park.

Commissioner Silverstein made the following motion:

WHEREAS, Dupont Circle ANC 2B is the elected body representing approximately 20,000 residents of the Dupont Circle neighborhood of Washington, DC, and

WHEREAS, the western border of Dupont Circle ANC 2B includes a portion of Rock Creek Park, and

WHEREAS, deer ticks spreading Lyme Disease have become a serious health hazard in areas of the park bordering on ANC 2B, with several constituents reporting they and/or their pets have suffered tick bites and/or Lyme Disease, with some areas of the park so overrun by ticks that they are now avoided completely, and

WHEREAS, the National Park Service is seeking public comment on its plan to manage the population of white tailed deer within Rock Creek Park, a population that has been growing steadily in recent years in the absence of any predators,

THEREFORE, BE IT RESOLVED that Dupont Circle ANC 2B supports the need to immediately reduce and bring the white tailed deer population within the Park under control, as a matter of public health and safety, and

BE IT FURTHER RESOLVED that Dupont Circle ANC 2B urges the National Park Service to do so as safely and humanely as possible.

Commissioner Wexler seconded the motion. The motion carried (6-0-3) with Commissioners Stephens, Patel and Feldstein abstaining.

Resolution in support of K Street corridor transportation improvements option two, which includes designated busways and additional curbside space for delivery vehicles. (2B05 & 2B06)

Commissioner Stephens made the following motion:

Whereas, K Street is an important east-west Thoroughfare through ANC 2B, and

Whereas, DDOT is considering establishing a transitway that would speed bus travel along K Street, and there are three alternatives being proposed, and

Whereas, Alternative 1 is a no-build option;

Whereas, Alternative 2 would create a 2-lane bus transitway;

Whereas, Alternative 3 would create a third passing lane in the bus transitway and add a bicycle lane, but eliminate most curb-loading possibilities;

Therefore be it resolved that ANC 2B strongly supports dedicated bus transitways as a means to expedite and encourage mass transit usage along K Street;

Be it further resolved that ANC 2B strongly supports Alternatives 2 and 3 over the no-build option;

Be it further resolved that ANC 2B is concerned that the elimination of most loading and delivery possibilities from K Street will be untenable in practice;

Be it further resolved that ANC 2B supports safe bike lanes, either disconnected from K Street by a gutter or curb, or on the neighboring sidestreets of I “Eye” Street and L Street rather than K Street;

Be it further resolved that ANC 2B is concerned that travel time for east-west vehicular traffic not be unduly increased for automobile commuters that do not have a transit option.

Commissioner Feldstein seconded the motion. The motion carried unanimously (9-0).

Resolution on proposed Historic District regulations.

WHEREAS, the Office of Historic Preservation issued proposed new guidelines on February 12, 2009 for public input into the establishment of new Historic Districts within the District of Columbia, and

WHEREAS these tentative new guidelines included several ideas that may have been contrary to both the spirit and the letter of DC law and federal civil rights laws, and were clearly adverse to any community input that did not rubber stamp the objectives of the Office of Historic Preservation, and

WHEREAS, the Office of Historic Preservation has since revised its proposed new rules, to eliminate such controversial provisions as the requirement that opponents have their signatures notarized, and

WHEREAS, the proposed new rules provide requirement for greater community notice and participation, and

WHEREAS, the proposed new rules still provide no mechanism for voting or any definitive way for a neighborhood to approve or reject an application made by an outside group, and

WHEREAS, the essence of a participatory democracy is that the votes of those who participate are counted and those who do not vote are not deemed “in favor” by their acquiescence,

THEREFORE BE IT RESOLVED, that Dupont Circle ANC 2B hereby commends the Office of

Historic Preservation for improvements to the guidelines, and supports the various methods described therein to notify the public and seek public participation in the decision-making process, but

BE IT FURTHER RESOLVED that Dupont Circle ANC 2B OPPOSES approval of the proposed new guidelines until there is included among those options a community-wide vote to provide a clear and definitive gauge of community sentiment.

Commissioner Feldstein made a friendly amendment to remove “Chevy Chase” from the motion above. Commissioner Silverstein accepted the friendly amendment. Commissioner Carney seconded the motion. The motion carried unanimously (9-0).

Resolution in support of legislation to recognize two tiers of vacant property, with additional tax burdens for blighted vacant property

Commissioner Stephens made the following motion:

Whereas the District has been levying a tax of \$10 per \$100 of assessed value for certified “vacant” properties; and

Whereas the Council has considered legislation which would eliminate the additional tax burden for “vacant” properties and instead tax a new category of “blighted” properties;

Whereas the vacant property tax appears to have been effective in the Dupont Circle neighborhood in providing incentives for vacant property owners to make their properties useful and occupied; and

Whereas blighted vacant properties are a public nuisance which lead to structural damage on neighboring properties, rat infestation, criminal activity, and other problems; and

Whereas the Commission recognizes that in tough economic times, it may be difficult for well-intentioned vacant property owners to find interested financiers, buyers, or renters; and

Whereas the Commission recognizes that vacant properties can quickly morph into blighted properties if not provided the proper upkeep and care;

Therefore be it resolved that ANC 2B supports the concept of an additional tax burden on “blighted” vacant properties; and

Be it further resolved that in order to help prevent vacant properties from becoming more problematic blighted properties, ANC 2B supports the continuation of an increased tax burden on “vacant” property, though at a lower tax rate than “blighted” properties; and

Be it further resolved that the Chairman send a letter to the members of the D.C. Council in accordance with this resolution.

Commissioner Feldstein seconded the motion. The motion carried unanimously (9-0).

Commissioner Silverstein made a motion to support the following application, with the condition that the establishment does not block the neighboring bus stop. The motion carried unanimously (9-0).

Petition for speedbump in the 1700 block of Riggs Place. Presentation by Jonas Morris. (2B03)

Jonas Morrison requested approval and a letter of support from the Commission for installation of a speedbump.

Commissioner Meehan made a motion to support the application. Commissioner Jacobson seconded the motion. Commissioner Silverstein requested the Commission to table the matter until the November meeting, for further study of the issue. Commissioners Feldstein and Jacobson suggested requesting a study on the issue from DDOT.

ABC application #082860 for new retail Class “A” license for “fine wine shop with tasting” with hrs. Mon-Sat 9am-10pm at 1828 B 18th St. NW (2B08)

Commissioner Stephens suggested the Commission take no action. The Commission took no action.

ABC application #077839 for the Bards of Washington T/A James Hoban’s Restaurant, 1 Dupont Circle to extend sidewalk cafe hours and sale of alcoholic beverages on sidewalk cafe to: Sunday thru Thursday 11am-2am and Friday and Saturday 11am-3am. (2B02)

Commissioner Patel made a motion to oppose the application on the basis of peace, order and quiet. Commissioner Estrada seconded the motion. The motion carried (8-0-1) with Commissioner Feldstein abstaining.

Public Space application for awning above existing unenclosed sidewalk cafe at 1701 Connecticut Av NW by Foundation of Human Rights for La Tomate Restaurant. (2B02)

Commissioner Feldstein made a motion to support the application. Commissioner Wexler seconded the motion. The motion carried (9-0).

Administrative/Financial Matters

Presentation and possible adoption of annual budget

Commissioner Jacobson presented the Commission’s budget. The Commission could not approve its budget until Congress has approved its budget. Commissioner Silverstein noted we

could refer to our budget as “provisional”. Commissioner Jacobson made a motion to approve the provisional budget. Commissioner Stephens seconded the motion. The motion carried (9-0).

ANC 2B Policies & Procedures Manual Revisions

1. Requirement that each Commissioner be a member of at least one committee

Commissioner Stephens made the following motion:

Be it resolved that the following addition be made to the ANC 2B Policies & Procedures Manual:

1. “Each Commissioner shall be a member of at least one committee.”

Commissioner Jacobson seconded the motion. The motion carried (9-0).

2. Requirement that each formal letter be signed by Chair + Vice Chair
Commissioner Stephens tabled this matter.

At 10:00 PM, Commissioner Silverstein moved to adjourn the meeting, which passed by acclamation.

The next regular meeting of ANC 2B will be held on Wednesday, November 11, 2009, 7:00 PM at the Brookings Institution, 1775 Massachusetts Avenue, NW - 1st Floor, Falk Auditorium .
