VOLUNTARY AGREEMENT

THIS VOLUNTARY AGREEMENT, made on this <u>W</u>day of <u>August</u>, <u>2010</u>, by and between Mezza Luna, Inc., t/a Mezza Luna, ("Licensee"), and Advisory Neighborhood Commission 2B ("ANC 2B")

RECITALS

WHEREAS, Licensee is the holder of a Class CR license issued by the ABC Board for premises known as 1140 19th Street N.W., Washington, D.C. 20036; and

WHEREAS, License is adjacent to another restaurant in said building, and both parties share a common wall;

NOW, THEREFORE, in considerations of the Recitals set forth above, and the mutual covenants in agreements hereinafter set forth, the parties agree as follows:

- 1. The Recitals set forth above are incorporated herein by reference.
- 2. Licensee is given permission to have a DJ in connection with the leasing of the premises for a private party. Licensee is given permission to have a DJ in connection with its business operations at any time after 11 PM. The DJ will take the necessary steps to insure that the music will not be heard and the bass will not be felt in the adjacent premises until after 11 PM.
- 3. Licensee will not participate in any pub-crawls or other bar and club events. However, Licensee be permitted to participate in Restaurant Week and Taste of D.C.
- 4. Licensee agrees to operate in full compliance with all applicable laws and regulations.
- 5. The Agreement shall be posted alongside the liquor license and other licenses on the premises. Licensee and the ANC hereby request that the board incorporate the text of this Agreement in order to approve the substantial change.
- 6. In the event of a violation of this Agreement, the ANC shall notify the Licensee. If the Licensee does not correct any violation of the Agreement within five days, then ANC shall have the right to petition the ABC Board for show cause hearing.
