RE: Application by Fuel Pizza, 1747 Pennsylvania Avenue, for a new Class CR (restaurant – full service) license and stipulated license. Contains sidewalk café endorsement. (2B06)

Dear Chairwoman Miller,

At its regular meeting on July 10, 2013 the Dupont Circle Advisory Neighborhood Commission (“ANC 2B” or “Commission”) considered the above-referenced matter. With all of the Commissioners present, a quorum at a duly-noticed public meeting, the Commission approved the following resolution by a vote of (8-0):

Whereas; at its regularly scheduled meeting on July 10, 2013 the Dupont Circle Advisory Neighborhood Commission 2B (“ANC 2B”) considered a request by Fuel 1747 Penn, LLC (“applicant”) trading as “Custom Fuel”/“Fuel Pizza” for a new Retailer’s Class C/R ABC License and transfer of Existing Sidewalk Cafe permit, located at 1747 Pennsylvania Avenue, NW, (formerly the site of Upper Crust Pizza), and;

Whereas; the applicant has requested that ANC 2B support the issuance of a Stipulated License in accordance with Section 200 of Title 23 of the District of Columbia Municipal Regulations, (“23 DCMR §200”), to operate under the terms of that license application prior to the completion of the 45 day protest period, and;

Whereas; the FUEL PIZZA restaurant group presently operates establishments in the District of Columbia including one located at in ANC 2B, and another in ANC 2C, both of which had previously been granted stipulated licenses at the request of their respective ANCs;

Now therefore be it resolved; that ANC 2B supports the request by Custom Fuel/Fuel Pizza for a new retailers C/R license with a sidewalk café endorsement, and supports the request for a stipulated license.

Due to his position on the ABC Board, Commissioner Silverstein did not participate in the vote.
