At its regular meeting on October 14, 2009, the Dupont Circle Advisory Neighborhood Commission ("ANC 2B") or ("Commission") considered the above referenced matter. - Policy, 1904 14th Street (2B09)


We are aware that blocking a bus stop violates the rules, but we seek to provide notice to all that there have been problems reported in the past, and expect the rules to be followed in the future.

The Public Space Committee (PSC) has received an application for a Standard Valet Parking Permit from **POLICY**. The request is for a Valet Staging Zone of **2** parking spaces adjacent to **1904 14TH STREET NW**. All vehicles will be parked in an off street parking facility located at **1810 14TH STREET NW**.

The PSC is providing ANC 2B the opportunity to comment on this request for a Valet Staging Zone. This application is for an existing valet parking operation that now falls under the new Valet Parking regulations (DC Register June 26, 2009; full text available at www.ddot.dc.gov).
