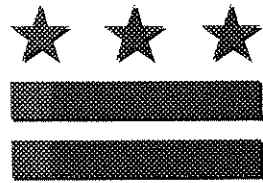
This agreement is entered into in order to preserve and maintain the peace, order, quiet, safety and cleanliness of the neighborhood.
