WHEREAS, ANC 2B has filed a written objection to the approval of the reissuance of the License pursuant to the provisions of D.C. Code §25-602(a); and



- 3. Applicant shall provide to ANC 2B the name and contact information for the manager of the Premises, or the District Manager, and shall keep ANC 2B advised of any changes in the names or contact information.
 - 4. ANC 2B hereby withdraws its protest and joins with Applicant in requesting the Alcoholic Beverage Control Board to accept this Agreement as a condition of approval to
