Re: Incorporating an ANC Exception to the Hatch Act

Dear Congresswoman Norton,

At its regular meeting on October 13, 2010, the Dupont Circle Advisory Neighborhood Commission ("ANC 2B" or "Commission") discussed the limitations of the Hatch Act as applied to ANC Commissioners. With eight of nine Commissioners present, a quorum at a duly-noticed public meeting, the Commission approved the following resolution by a vote of (8-0):

Whereas in October 2009, ANC 2B passed a resolution encouraging Delegate Eleanor Holmes Norton and Congress to allow D.C. to pass its own D.C.-specific Hatch Act which would exclude ANC Commissioners from coverage;

Whereas currently the Hatch Act restricts D.C. Government officials from, among other things, hosting a fundraiser for a partisan candidate, raising funds for a partisan candidate, or being a candidate for partisan office;

Whereas the Hatch Act includes an explicit exception for certain elected D.C. officials, including the Mayor and the Council, but not ANC Commissioners;

Whereas the U.S. Office of Special Counsel has thus interpreted the Hatch Act to apply to ANC Commissioners, despite there being admittedly no enforcement mechanism against ANC Commissioners;

Whereas it is nonsensical to apply the Hatch Act's restrictions on fundraising and campaigning to any elected officials, including ANC Commissioners;

Whereas the November 2010 D.C. ballot will include a referendum to make the D.C. Attorney General an elected office, meaning the District would have another city-wide, partisan, elected official;

Whereas if the Attorney General measure passes, Congress will have to amend the Hatch Act to exclude this new elected office from coverage, and this provides an opportunity to also amend the Act to explicitly exclude ANC Commissioners;

Therefore be it resolved that ANC 2B respectfully urges Delegate Norton and Congress to amend the Hatch Act to explicitly exclude elected ANC Commissioners from coverage.
